How did we obtain your personal data?

marXact has obtained your data because you have provided that information to us.

What are your rights?

Under the European General Data Protection Regulation, you have a number of rights with regard to your information and the processing thereof:

Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal information that has been collected by marXact, you may exercise your right of access by submitting a request to marXact.

Making changes

If you wish to make changes to the personal data that you have seen as a result of a request for access and that you cannot change yourself in your account, you can request this at marXact. You can ask that marXact modifies, corrects, supplements, deletes, or screens your data. Limiting the processing of personal information.

Restricted processing

You also have the right, under certain conditions, to ask marXact to restrict the processing of your personal information.

Objections

If a certain processing takes place on the grounds of the 'legitimate interest' of marXact or a third party, you have the right to object to that processing.

Transferring of data

You have the right to obtain your personal information from marXact. marXact will provide these in a structured and familiar format, which can easily be opened using popular software.

Automated processing

Whenever a decision about you is taken that is completely based on automated processing of your personal data, you have the right to request that that decision be re-evaluated by a person. You may at all times let us know your position on that decision or let us know that you do not agree.

Withdrawing permission

When the legal basis for a particular process is your explicit consent, you have the right to withdraw that consent. This does not affect past processing but does mean that we will no longer be allowed to process this information in the future. It may also result in marXact no longer being able to provide you with certain services.

Response from marXact

A request can be sent to info@marxact.com. marXact will comply with your request as soon as possible and in any case no later than one (1) month after marXact has received such a request. If marXact rejects your request, we will indicate in our reply why the request was rejected.

Recipients of your personal data

It is possible that marXact is required to submit your data to a third party, for example to fulfil a legal obligation.

Automated Decision Making

marXact can use automated decision-making processes based on your data. It is possible that, based on your profile, some of our products or services marXact may not be available.

What are cookies and how does marXact use them?

marXact only uses technical and functional cookies. Cookies are small pieces of (text) information that are sent to your browser when you visit the website of marXact and then stored on the hard disk or in the memory of your device. The cookies placed via marXact's website cannot damage your device or the files stored on it. When we talk about 'cookies', we also mean comparable techniques with which information is collected, such as device fingerprinting. You may opt out of cookies by changing a setting in your internet browser so that it does not store cookies anymore. In addition, you may also delete all information previously saved via the settings of your browser.
